A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MARION COUNTY, FLORIDA, ESTABLISHING FEE SCHEDULES FOR CONTRACTOR LICENSING, CITATION FEES AND PROVIDING AN EFFECTIVE DATE.	
WHEREAS , the Board of County Commissioners of Marion County, Florida is authorized to establish fees pursuant to Marion County Ordinance No. <u>01-34</u> ; and	
WHEREAS , the Board desires by this Resolution to establish fees for the administration and enforcement of said Ordinance.	
NOW, THEREFORE , be it Resolved by the Board of County Commissioners of Marion County, Florida:	
<u>SECTION 1. CONTRACTOR LICENSES, COMPETENCY CARDS AND OTHER LICENSING ISSUES.</u> The Building Department shall charge the following fees for Contractor Licenses and Services.

2A-1 Falsely hold himself or a business organization out as a licensee, certificate holder, or registrant.	1 st Violation \$250.00 2 nd Violation \$350.00 3 rd and Subsequent Violations \$500.00

2B-4	Commencing any job without obtaining the applicable local building department permits.	Each Violation \$500.00
2B-5	Performing any act which assists a person or entity in engaging in the prohibited unlicensed and unregistered practice of contracting.	Each Violation \$500.00
2B-6	Using a subcontractor not authorized for use on the building permit, without first notifying the building department in writing.	1 st Violation \$200.00 2 nd and Subsequent Violations \$400.00

2B-8	Committing fraud or deceit in the practice of contracting.	Each Violation	\$500.00
2B-9	Knowingly or negligently violating the applicable building codes or laws of the State or County.	Each Violation	\$500.00
SECTION 3. REFUND FEES. No refunds shall be given for processing fees, application fees, licensing fees, or citation fees unless collected in error by the Building Department.			
SECTION 4. REPEAL. Resolution No. 99-R-280, of the Board of County Commissioners of Marion County, Florida, is hereby repealed.			
SECTION 5. EFFECTIVE DATE. This resolution shall take effect on October 1, 2004.
